



## 2017 GHRA BOARD OF DIRECTORS NOMINATIONS October 10, 2016

**NOMINATIONS BEING ACCEPTED FOR GHRA BOARD POSITIONS:** The Guam Hotel & Restaurant Association's Annual Election for its Board of Directors is scheduled for Friday, November 11, 2016 at the fourth quarter General Membership Meeting at the Westin Resort Guam.

GHRA requests all qualified Active and Allied Members to submit nominations for candidates to serve on the Board of Directors. All qualified nominees will be considered for placement on the ballot for election subject to the acceptance of the nominee. Qualified members are those members on record who are in good standing and have no overdue or disputed balances with GHRA.

The Guam Hotel & Restaurant Association by-laws provides for a nine (9) member board serving a maximum of two, two (2)-year staggered terms. The board is composed of five (5) hoteliers, two (2) restaurateur and two (2) allied industry members with the tenth member appointed by the nine (9) elected directors.

For election 2017, a maximum of two (2) Hotelier Board Members, one (1) Restaurateur Board Member and one (1) Allied Chapter member totaling four (4) will be elected to serve one two-year term beginning January 1, 2017.

Board meetings are held monthly on the third Wednesday of every month at 10:30a.m. The 10<sup>th</sup> member is a Board elected position and not eligible for members votes.

Eligible for re-election are Mr. Joe Blas and Mr. Roy Abraham, representing Hotelier Chapter and Mr. Jim Herbert, representing the Allied Chapter. Not eligible for re-election is Mr. Basu Sudipta.

Continuing in their capacity as board members for calendar year 2017 is Ms. Sophia Chu Wigsten, Mr. Steve Solberg and Mr. Toshi Doi representing the Hotelier Chapter; Mr. Darren Talai representing the Restaurateur Chapter; and Mr. Edson Lai, representing the Allied Industry Chapter.
