President Rhodes provided a copy of the Coronavirus Task Force report and updated the board on the tourism economic recovery plan from GVB, projects and initiatives with UOG and DPHSS including the contact tracing certification course, Guam Covid Alert App, digitizing of the customs forms and Pathcheck, Abbott rapid test equipment, and efforts standardize the health and safety protocols by establishing the Guam Safe Certification program with UOG, GCC and GVB in support of the WTTC "Safe Travels" designation and seeking funding for a rapid test pilot program for the private sector

<u>Virtual Membership Meeting</u>

President Rhodes also updated the board on the On-Premise alcohol for take out / delivery services with closed, sealed containers. GHRA continues to conduct media interviews and hold stakeholder meetings and government meetings with the Guam Women's Chamber of Commerce and Guam Chamber of Commerce. Senator San Agustin introduced the draft bill for the sale of on-premise alcohol for take out / delivery services as well as proposed changes to the statues to modernize the ABC laws. A public hearing is scheduled for October.
