*Refresher Course is for those who are in the renewal period of their health certificate (30 days or less from expiration or no more than 30 days after expiration).

**Interim Course is for those who are first-time applicants or whose health certificates have expired more than 30 days.

To avail of this FREE health certificate course, exam and certification, the employer must complete this registration form and submit it to GHRA. All registration forms must also have the completed Food Facility Health Certificate application, which is are due the Thursday prior to registering for a Monday class AND only after the registrant has completed a PPD Skin Test. With the completed documents, GHRA will provide a voucher to turn in to DPHSS' DEH Processing Center Section along with the Health Certificate Clearance Application that requires a physician and/or clinic to complete, sign, stamp, and date the second and third page of the form. If this is the first time for individual(s) applying for a Food Facility Health Certificate, please click here https://dphss.guam.gov/wp-content/uploads/2020/08/01.-HC.FOOD 2018.pdf

Once the results are confirmed and it is under 10mm, individual(s) can bring in their application to the DPHSS' DEH Processing Center Section to receive a temporary Health Certificate and/or be scheduled for the food safety training course and test. All registrants will need to bring in a photo ID (driver's license, passport, etc.). Additionally, if the PPD skin test result is 10 mm or higher, the individual(s) will need to visit the DPHSS TB Program at Northern Regional Community Health Center (Dededo/Northern Public Health) to get cleared before applying for a Health Certificate.
